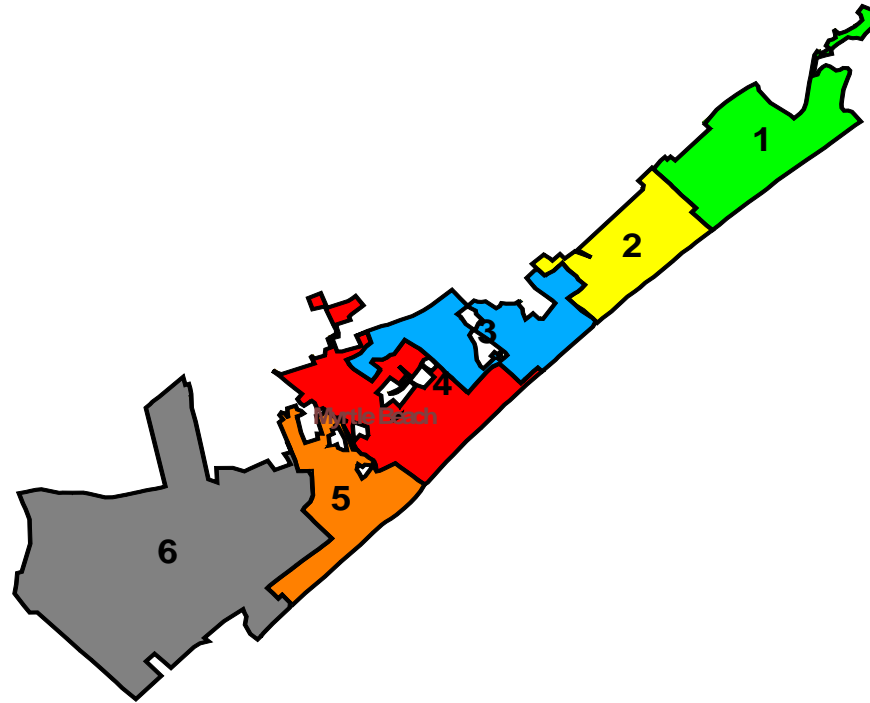

- **KNOW CONCERNS OF GROUP**
- **DISCUSS REDISTRICTING CRITERIA**
- **PROVIDE COPIES OF MAPS & REPORTS**
- **DETAIL STREETS & LANDMARKS**
- **AVOID TERMS LIKE “MAXIMIZATION”**
- **ADDRESS OVERALL FAIRNESS OF PLAN**

# ELECTED OFFICIALS

- KNOW CONCERNS OF GROUP
- DISCUSS REDISTRICTING CRITERIA
- PROVIDE COPIES OF MAPS & REPORTS
- DETAIL STREETS & LANDMARKS
- TERMINOLOGY
- ADDRESS OVERALL FAIRNESS OF PLAN
- IDENTIFY INCUMBENT ADDRESSES
- EMPHASIZE CHANGES FROM CURRENT DISTRICT
- KNOW PRIOR REDISTRICTING CASES INVOLVING JURISDICTION

# PUBLIC HEARINGS

- **EMPHASIZE REDISTRICTING CRITERIA**
- **IDENTIFY SUBMISSION REQUESTS OF COMMITTEE:**
  - *RETROGRESSION, LEGAL BENCHMARK, MAJORITY-MINORITY DISTRICTS, GINGLES FACTORS, SPLITS, ETC*
- **BE PREPARED TO ADDRESS DIFFERENCES BETWEEN YOUR PLAN AND POSSIBLE LEGISLATIVE PLANS**
- **TERMINOLOGY**
- **KNOW PRIOR REDISTRICTING CASES INVOLVING JURISDICTION**
